MINISTRY INSPECTION -UPDATE

The Ministry is currently in the Home to complete their follow up inspection for the Compliance Orders noted during the RQI (Resident Quality Inspection) of May 2017. Based upon the inspection, the Home was placed in "Cease of Admissions" effective October 2, 2017 until areas were corrected. We are anticipating that these areas will be cleared but until the Inspection is completed this can not be validated. An update will be provided to all residents and families upon completion by means of separate communication.

Foot Care Services: Based upon the requirements of the Inspection report, the Home needed to contact families to have foot care services reviewed and new consents signed if resident/family continued to have Podiatry services. If you have not already returned the consent form, please do so at your earliest convenience to the Nursing Department.

Podiatry Reimbursement: There are still a few families who have not yet returned the signed form back to the Home in regards to Podiatry reimbursement based upon the Ministry's expectation. We do need to be able to prove to the Ministry that all families have been contacted, have received the reimbursement and provided the signed form back to the Home—this could potentially hold up the clearing of this Compliance Order—if you have not done so, please return the signed form either in person, by email or regular mail to the Business Office.
